The meeting was called to order at 7:03 PM by Mayor Paulson

Public Comments: Idella Stinson 26 E 3rd St., commented on the election propaganda going out. Andrea Larsen 657 N Moss St., questioned the propaganda statements. Hall O'Regan 62 E 3rd St., made a comment on a need to change city name, if things don't change. Ken Larsen 657 N Moss St., made a comments about discourse in town.

Council Comments: Mayor Paulson commented that he just came from the Welcome Back to School dinner and that they're doing a good job. Mayor Paulson also clarified that 'The Bridge' is sponsored by the city, fire district and school district. Councilor Rennert would like to see the Oakridge Police Log for Lowell.

- Parks Ordinance: Mayor Paulson reviewed previous work done on ordinance. Discussion followed. Councilor Reese, I hereby make a motion that this Council approve the attached proposed revised Ordinance 5.060: An ordinance adopting Lowell Revised Code Sections 5.053 related to smoking in City Parks, alcohol use in City Parks, park hours, and related clerical changes, in its entirety as it is so written by Council Member Reese, and to further direct the City Administrator to proceed with all steps necessary to adopt said Ordinance. Seconded by Mayor Paulson. Discussion followed. CA to have ordinance ready for first reading and public hearing at next council meeting. Mayor Paulson moved to amend draft ordinance

as follows, to add paragraph E, The Lowell City Council may establish such additional rules and regulations related to these items as it deems appropriate. Seconded by Councilor Knokey.
